

## Course Information

### DESCRIPTION OF THE COURSE

This international course, taught in English, is **interdisciplinary** in nature.



It deals extensively not only with the legal matters, but also touches upon other disciplines such as history, politics, science, philosophy and sociology.

The main aim of the course is to analyze the functioning of law and its institutions as regulating mechanisms of social conflicts in present-day Europe. Specific emphasis is given to the real day-to-day functioning of those mechanisms and to the **role of proper functioning of justice for the development of social and democratic culture** and institutions. Within this scope, the course in particular discusses the processes in the countries which undergo fast change, such as **transition countries**, but also the processes in the **leaders of change**, such as the countries of Northern Europe.

The course focuses on the ongoing **reforms in the justice systems**, especially on resolution of civil disputes, both in the field of general civil disputes and in specific areas. Equal attention is given to state established and controlled mechanisms (such as judiciary and legal aid) and those established and controlled by civil society (such as private mediation and legal assistance provided by NGOs).

### PARTICIPANTS

The target participants are:

- **Scholars, experts and students** engaged and/or interested in civil dispute resolution and the reforms in justice system;
- **Legal practitioners** (judges, lawyers, mediators) who have an interest in in-depth study of the functioning of justice;
- **Policy makers** (state officials, heads of judicial administration, members of drafting committees) interested in the assessment of impact of policies in justice sector;
- **NGO activists** and civil society organizations' representatives engaged in the matters of legal aid and reforms of the judiciary.
- **Members of international organizations** which are instrumental in the reforms of the justice sector.

### PARTICIPATION FEE and COST

All participants are expected to cover the IUC course fee of €40. There will be a limited number of scholarships available to participants.

### Topics for 2010

Current topic is devoted to the development of legal professions in Europe. This is a topic that is of interest from a general European perspective, in which European law and the processes of globalization influence the way how particular legal professions operate. It is also significant from local and regional perspective, since the heritage of socialist law have had a decisive impact on the balance of public and private legal professions.

The selected 2010 topics are, inter alia:

- *Quo vadis, legal profession: What will be the jurist of 21<sup>st</sup> century?*
- *Restoring tradition in Eastern Europe?*
- *Judges, attorneys, notaries, bailiffs – where is their common ground?*
- *Competition or collaboration: division of work among different professions*
- *Theory vs. practice – the role of legal academy today*
- *Emerging new legal professions? Arbitrators, Mediators, Consultants*
